## AFFIDAVIT OF FINAL COST INSTRUCTIONS

### SECTION ONE

Contract Holder Information

- **Company Name:** Type/Print the name of the company as it appears on the EZ Contract
- **Contract Number:** Type/Print the EZ contract number as it appears on EZ contract
- **Complete Address of the EZ Project Site :** Provide the address of the business
- **Parish of the EZ Project Site:** Enter the name of parish where the project is located
- **Facility Phone Number:** Phone number of the facility where contact person can be reached
- **Contact Person Name and Title for Plant/Facility Inspection:** Enter the name of the person a LED representative would contact to schedule a site visit
- **Contact Phone Number:** Provide the phone number of the plant/facility contact person
- **Contact Email:** Provide the email address of the plant/facility contact person
