Reimbursement of coach class airfare that adheres to the Fly America Act

Lodging up to the federal per diem rate

Ground transportation fees

Meals up to the federal per diem rates

Registration fees and booth fees

TO BE ELIGIBLE COMPANIES MUST:

Have been in business for at least one year

Operating profitably

Be based in Louisiana

Have a plan for exporting (strategy)

Understand the costs associated with exporting (costs such as freight forwarders, customs brokers, shipping...)

Meet the SBA definition of a small business (generally defined as less than 500 employees)

Not be debarred from doing business with the Federal Government

The company can either be new to export or seeking market expansion

Funded in part through a Cooperative Agreement with the U.S. Small Business Administration.
