- Mr. Rutledge, Mike Polito and Terrie Sterling provided brief opening remarks thanking the members for serving.
- The Task force agreed to support the following as submission to the commission regarding the 'reopening' of the economy:
 - The construction industry task force has been requested to identify how to re-open. The
 construction industry has remained open as an essential workforce and has led the way providing a
 safe workplace for its employees and the public. The industry is proud of its accomplishments and
 hopes to have paved the way (no pun in intended) for others to follow.
 - We recommend going forward that industry members follow the current CDC and OSHA guidelines tailoring their specific approach to these guidelines and as projects elements demand.
 - We also submit other external resources for the industry to consider as submitted by GNO inc. BRAC and AGC.
- The Members and representatives of AGC, AIA, ABC, ACEC discussed the impact of the Covid-19 virus on their business and what short term solutions could be implemented. Among those items discussed:
 - Legislative or Executive Order regarding treating the Liability aspect of the Virus. It should be treated like any other contagious diseases.
 - Contract language was being inserted in Contracts making the Contractor responsible for any future impacts of the virus...delays, cost increases, etc.
