In accordance with Executive Proclamation JBE 2020-59, issued by Governor John Bel Edwards on May 14, 2020, the Resilient Louisiana Commission ("RLC") is providing for attendance at essential commission and task force meetings via teleconference or video conference as allowed during the pendency of the COVID-19 health emergency. Pursuant to Section 2C of JBE 2020-59, the RLC Hospitality and Tourism Task Force will provide attendance for the 2:00 p.m. meeting on Tuesday, May 26 via Zoom and in a manner that allows for observation and input by members of the public, as set forth in the Notice posted on May 22. The Hospitality and Tourism Task Force would otherwise be unable to operate due to quorum requirements.
