Motion 1: To adopt Robert's Rules of Order for purposes of voting on accepting Task Force reports – majority voting, not consensus. The Commission should vote on Task Force recommendations up to a week after receiving them to give Commission members enough time to digest the material.

Motion 2: To assign a member of the Commission to each Task Force based on industry expertise.

By: Scott Hensgens Second: Rep. Paula Davis No public or member opposition

- Sen. Ronnie Johns: Task Force members should be included in Commission meetings to have situational awareness. No objections, general agreement.
- Kim Robinson: Task Force recommendations should be consistent with guidelines from federal officials/agencies and Gov. John Bel Edwards.
- Tim Temple: Volunteered to serve on the Transportation Task Force, and the Financial Services, Insurance and Real Estate Task Force.
- Various members: There's no definitive legislative schedule. Sec. Kimberly Robinson stated that the Commission should still adhere to the timeline in the RLC process document.
