C&I would otherwise be unable to operate due to quorum requirements.

#### **Public Comment**

##### Prior to the meeting

Prior to the meeting, public comments should be submitted to LED via email. These emails will be received up to 3:00 p.m., Monday, June 22, 2020. If you wish to speak during

the meeting, please indicate this preference in your email, otherwise your written comments will be read for inclusion in the meeting record.

#### During the meeting

Anyone who wishes to speak shall have the opportunity to do so. The Chairman will open the floor for public comment and will allow for comments by speakers in the order received. Public comment will be received first by those attending in-person, followed by those participating via Zoom. If using Zoom, use the “raise your hand” function or “chat” function during the respective program (QJ, RTA, EZ, &ITE) section of the agenda to present your comment. The Q&A function will not be used or monitored. Specific instructions are outlined in “Zoom Instructions” below. Public comment will be limited to three minutes.

Please remember to speak clearly, slowly, and louder than your normal voice, so all board members and those in attendance can hear your questions/responses.

#### **In-person Meeting Attendance Protocol**

All persons attending the meeting in person shall utilize appropriate protective health measures, social distancing and observe the protocols below:

1. Everyone entering the LaSalle building must go through the temperature checkpoint at the building entrance facing North Third Street. (Please allow extra time to go through the temperature checkpoint.)
2. Everyone entering the building and LaBelle room **MUST** practice social distancing, and wear a face mask at all times.
3. Everyone **MUST** follow the signs placed on each row of the seating area to maintain appropriate social distancing.
4. The maximum number of attendees allowed for this meeting in the LaBelle room is **50** people.
5. All in-person attendees will be seated by program as per the agenda. For example, those in attendance for QJ, RTA, and EZ projects will be permitted to enter the 9:30 a.m. session. Due to the limited seating capacity of the room, LED is asking that attendees be limited to 1-2 representatives per applicant, as well as any organization/group seeking to address the board on the application. To allow others to enter the LaBelle room for their respective project, we kindly ask that once your project has been heard, you exit the room. This will allow LED staff to accommodate those who may be waiting in alternative locations to be seated in the LaBelle room for their project application being presented to the C&I.
6. After temperature checkpoint processing, LED staff will direct you to either the board room, if you are attending the 9:30 a.m. session (QJ, RTA, EZ), or to one of the waiting areas if you are attending the 10:15 a.m. ITEP session, or should the room capacity be at 50 attendees. Overflow areas have been set up in the LaSalle cafeteria and the Welcome Center located between the LaSalle Building and the Pentagon Barracks. A LED staff person will be stationed in the overflow areas and will notify those waiting when seating in the main boardroom is available, or at the start of the next session. LED staff will provide specific directions on the day of the meeting. In the overflow areas, everyone **MUST** always practice social distancing and wear a face mask.
