LED has recently done research on the RIO for the Quality Jobs Program, and it is estimated to be \$1.92 for every dollar of investment. Of course, what we do is we look at all of the projects and all of the direct and indirect economic impacts associated with the projects that have completed in the past, and that's where we derive that number.

I believe you may be aware in the future the Department of Revenue has been authorized to develop an ROI for all incentive programs, tax credits, rebates, deductions, exclusions and whatnot, so they'll be doing some extensive research in the coming months I believe.

From the past, Ms. Mitchell, and today,
I guess, do you see that there's an uptick in the return
on investment or is it stable? I mean...

### MS. MITCHELL:

So the last time we did that research, I think we were at about 1.80, so we have seen an improvement in the ROI, but, again, we're in the midst of taking a look at how we evaluate that and ensuring that it meets with national standards. There are actually some states, I can't call which state it is, it may be Wisconsin, that has an estimated ROI for their QJ Program, their similar program, as high as \$4 for every dollar of investment. So there are different methodologies used, but the methodology that we have used in the last couple years has resulted in roughly \$1.92 for ever dollar invested in the Quality Jobs Program.

### MR. DEVILLIER:

Well, I thank you for all of the work that you do for our state. I know you do a great job. I appreciate it.

This is going to be a question that I'm going to ask on a lot of these programs to see what type of return we're receiving on the state's dollars. So thank you.

one point any company could locate anywhere in the state and participate, whether they were in Enterprise Zone or not, and that caused the cost of the program to grow exponentially over a number of years, and so what we did is we looked at the policy purpose of the program. And we understand that workers today are mobile, so we didn't want to recommend a restriction that companies locate in physically in an Enterprise Zone; however, we tweaked the incentive to require -- to allow for higher incentives for companies that either locate in a zone or hire economically-disadvantaged individuals. And so by doing so and adding some over-tightening measures to the program, we have actually seen just kind of organically the cost, the overall cost of the program to decline every single year. So I think it, maybe last time I looked, it was maybe 25-million or so. I could pull those numbers for you.

### MR. DEVILLIER:

And whenever you look at, I guess, our overall tax policy, because that's how, you know, I'm having to look at these a lot through ways and means, when you look at the overall tax policy, and I know that Enterprise Zone is a little bit different because you're trying to, I guess, bring more development to maybe a depressed area. Would a better tax policy help in

regard to not having such as an Enterprise Zone Program or you think they need to work hand-in-hand?

### MS. MITCHELL:

Actually, no. Many states have a program similar to Enterprise Zone for that very reason, to try to encourage companies to locate in these areas to revitalize the area, to bring job opportunities to the individuals that live in these areas, to combat blight, you name it. There are a number of reasons that the Enterprise Zone is used, and it's very popular across the entire country, so I don't see a better approach to utilizing this program.

As a matter of fact, every single one of LED's incentive programs, when you look at the big picture of our tax structure in the state, we're very aware that there are over almost 300 exemptions that are in the tax code. But LED's programs, which there are 13 of them, are taxed based, and as you know, with ITEP, some are property tax driven, local tax driven, so some state tax, some local tax. Every single one of our programs has a specific policy purpose, a specific economic development policy purpose. So LED's programs are not designed just for the sake of lowering the company's tax burden, if you will.

So the R&D tax credit is designed to



1	spur research and development in our state and
2	partnerships with higher institutions. The Angel
3	Investor tax credit is designed to support startup
4	companies and entrepreneurs in our state. The Quality
5	Jobs has a set number, a pre-identified number of
6	industry sectors that we're intentionally targeting.
7	That's why we have the Quality Jobs Program. It's not
8	for every single company that wants to pay \$18 or more.
9	There are set industry sectors. Same thing with
10	Enterprise Zone.
11	MR. DEVILLIER:
12	So back on the Enterprise Zone, you had
13	mentioned the overall state's investment of around
14	25-million was reduced over the, I guess, most recent
15	years. What was it, let's say, four years ago?
16	MS. MITCHELL:
17	Oh, that number was maybe close to
18	100-million.
19	MR. DEVILLIER:
20	So it's gone from 100-million to
21	25-million?
22	MS. MITCHELL:
23	Yeah. If you give me a moment
24	MR. DEVILLIER:
25	What causes that?

#### MS. MITCHELL:

I would say the changes to policy, changing the policy to bring it back to its original purpose. The program had been amended some time ago. What the amendment did was allow any company across the state, regardless of where they're located, to participate in the program, and so the cost of the program grew over time exponentially. So before the meeting is over, I can walk you through past years, past fiscal years, the total impact of Enterprise Zone. So that's what's causing the change.

And the other is we are seeing more companies paying a higher wage and more companies opting to participate in Quality Jobs. And we can't have the companies stacking tax credits. You can't participate in both programs for the same dollar of investment, and so those companies that are in one of those targeting industry sectors that pay at least 18 an hour, they can go for the Quality Jobs Program, but I'll have those --

### MR. DEVILLIER:

I know we're not on Quality Jobs now, but, I mean, since you brought that up, has the Quality Jobs Program, the overall state's investment there, has that increased over the last four years?

It has. It actually -- we had a year in which it spiked as we had some significant projects. We are now dealing with projects in the order of the billions, and so we did see a spike for a couple years, in 2016, 2017, and that program has since levelled off. And so we report these numbers to the revenue estimating for the Revenue Estimating Conference, so we provide these forecasts, but it's leveled off. I think it's about 150-million for Quality Jobs.

### MR. DEVILLIER:

Thank you.

### SECRETARY PIERSON:

One of the other significant reductions that occurred in that Enterprise Zone Program was the elimination of the opportunity for retail to participate in and the healthcare industry to participate. If you're in a rural parish, if you're in Delhi, a Dairy Queen probably feels like economic development for you, but we had too much retail. Legislature looked at the program and eliminated that kind of participation, so that was another contributing factor to the lowering of the investment that the state is making in these

programs that drive jobs. And we're really happy to see a spike in Quality Jobs because it means we're being very successful in recruiting high-paying jobs that are providing healthcare benefit, and if the return on it's \$1.92, then I want to do that as much as I can.

Thank you.

### MS. MITCHELL:

Yes. And I do have a number. So, for example, Enterprise Zone in FY 14 was 50-million, and it's steadily declined from that point in time. So I think in the last year it may have reached 25-million.

And one other thing about the point on retail and healthcare. What the legislature decided, Rep Devillier, was to eliminate industry sectors where you see high substitution effects or industry sectors that are driven purely by demand or by population density. So a retail outlet is going to locate where the population density makes sense for them regardless of what the incentives are provided, so...

### MR. DEVILLIER:

Do you mind if I just ask one other question? I don't want to cut in front of you?

Do you have any programs that are administered through LED that actually lose money on investments?



### 1 MS. MITCHELL: 2 We do, and those programs have a different policy purpose. And, for example, the film 3 4 tax credit, which we report on that program every year, it does not have a positive fiscal impact, but it does 5 6 have a positive/net positive economic impact. every dollar invested in the film program, it's roughly 7 8 \$6 circulated in the community to local Louisiana-based 9 companies. And we can talk about film reforms all day, 10 but we do have --11 MR. DEVILLIER: 12 What's the state's return on investment 13 in the film industry? 14 SECRETARY PIERSON: 15 Well, we're doing approximately 16 \$150-billion a year allocation in credits in that 17 program, but what Mandi points out here is that when you 18 look at the state's investment, that return is rather 19 low --20 MR. DEVILLIER: What is it? 21 22 SECRETARY PIERSON: 23 -- but when you look over at the parish,

Yes, sir, and mine was actually just a little bit of history, as I recall, having served on the Shreveport City Council 20 years ago -- but, Mandi, I just wanted to ask a quick question. It seemed to me like, in the other century, that the whole idea behind this particular program was to try and incentivize businesses to locate in those determined economically impoverished census tracts and that it was expanded at some point because the businesses said "Well, if you would give us the incentive to hire persons who live within that determined census tract, that would assist the state in trying to bring some economic development into those areas."

And I know at that point it was almost as if the whole state at that point became a part of this program.

But you had mentioned, and I think the Secretary did a good job of saying that what we found out was that for all the best intentions, it kind of expanded into something we never envisioned doing. But you had said y'all had to bring that back down, the Department is trying to work to make sure that it comes back to what its original intention was.

### MS. MITCHELL:

We worked with the legislature on Yes. a series of reforms over probably three different legislative sessions with Enterprise Zone, and so instead of reverting all of the way back to the original design of the program to limit it to companies located in those census tracts, because nowadays workers are mobile, what we did in working with senators from particularly from the New Orleans area on these particular reforms is what we're doing is we're incentivizing companies with higher incentive return So if you locate in a census tract that is in an Enterprise Zone or if you hire a disadvantaged individual, your job tax credit is \$3,500 per net new job versus if you're not in an EZ, it's \$1,000 per net new job.

So what we did is we're using incentive policy to try to drive companies into those zones

One of the things that we're trying to do with our ITEP program is consistently implement improvements, and that's an ongoing activity at LED. And we have an idea here today that we wanted to introduce to the Board and the public, and the audience goes far beyond this room because it's a televised presentation.

Essentially the issue at hand is one that involves the local approval of projects, which we want to keep in place, absolutely, but one of the elements of a lot of our projects is that they'll have several phases. So if I would use an example, a company that wanted to build a coffee roasting facility might say I'm going to first build a steam generation plant, put it into service and sell some steam. Then I'm going to build my coffee roaster, roast coffee beans, and then maybe I'm going to come and mill green coffee beans so that I can put them back in the roaster. I'm going to have Phase 1, Phase 2 and Phase 3 of this project. probably going to take me 2020 to do the first one, 2021 to do the second one, 2022 to do the third one. And I spell all of that out in the Exhibit A, in the Cooperative Endeavor Agreement that goes before the public bodies. The public body sees the projects, the know that there's a sequencing, and they give approval.

Now, when the program started happening, that 10-year approval for the first part, maybe making steam, has got a start date, and then a 10-year exemption. Then when we come to build the roaster, it's a year later, so it goes on and will have a different term, which one year later, and a little longer on the far end. And then finally the third phase comes, and it's two years behind, so all of those are moving. Their paperwork comes back in through applications and confirmations that the investment has been made and the jobs are there.

But the idea that we would like to see to facilitate the program is just that once the local governing bodies have had the chance to see Phase 1, Phase 2, Phase 3 projected and they approve that, that there's not a requirement for the company to come back to do the next phase and the next phase. Those were already noticed to the public bodies, elected officials, so there's a clear understanding of the expectation and the deliverables with this.

So what we're doing would be to clarify that there's not a requirement to come back to the local bodies on each of these phases with the understanding that they're all clearly identified up front in the Exhibit A, Cooperative Endeavor Agreement, there's a

As I see it, when the project going to the local governments for their resolutions, they're going to present a multi-phased building plan, and when they present that multi-phase building plan and get the approvals from the locals, what we're saying is once they have that approval, they don't have to go back and approve it as each phase comes online.

project, we refer to that as a front-end project.

Historically, in order to ensure that no assets receive more than the maximum allowable exemption term, it has been and remains the practice of the Board to require separate ITEP contracts for each phase of a front-end project, which contracts are processed upon application to LED and approval by the Board. The contract for each phase of a front-end project falls under the same Advance Notification number, and the contract number for each phase is designated by the same number assigned in a front-end project's phases following with a letter. So if it's a three-phase project, it would be the same contract number, and then "A," and the second phase would be "B," and the third phase would be "C," et cetera, et cetera.

The potential phase for any given front-end project are articulated by year in the Exhibit A considered by the Board and the local governmental entities in approving the ITEP exemption for a project. This has been and remains the practice of LED since the inception of the Exhibit A requirement.

Because local government entities

approve front-end projects upon consideration of Exhibit

A, which include the potential phases for that project

by year and further provides that the Exhibit A is to be
